## GENERAL WAIVER, RELEASE & INDEMNITY AGREEMENT

In consideration of the opportunity to participate in the Group Lessons and with full understanding of the possible risk of injury and/or damage associated with my participation in said activity, I hereby **WAIVE** any and all claims for personal injury and property damage, of any kind or character whatsoever, against Crown Center Redevelopment Corporation, Hallmark Cards, Incorporated, and their subsidiaries and affiliates, their officers, directors and employees. I do hereby **RELEASE AND FOREVER DISCHARGE** each and every such person and entity from liability for any such claims which may arise from or occur as a result of my participation in the Group Lessons.
