

Official Rules Stocking Stuffers 2023 Giveaway Contest

OFFICIAL RULES

The “Stocking Stuffers 2023 Giveaway” Contest (the “Contest”) is open to legal residents of the 50 United States of America, including the District of Columbia. NO PURCHASE NECESSARY TO ENTER OR WIN.

ELIGIBILITY

The Contest is open only to legal residents of the United States, who are 18 years of age or older at the time of entry. Void where prohibited by law. Employees of Sponsor (see definition below), and Sponsor’s parent companies, affiliates, members, promotional vendors and other vendor agencies directly or indirectly involved in this Contest, and employees of any retail business in the Crown Center Shops or of Sea Life, Legoland Discovery Center or any other Attraction at Crown Center, as well as the immediate family members (spouse, parents, siblings and children) and household members of each such person, are not eligible. The Contest is subject to all applicable federal, state, and local laws and regulations. Sponsor retains the sole discretion to determine in good faith all questions regarding Entrant eligibility.

AGREEMENT TO OFFICIAL RULES

By participating, those who enter the Contest (“Entrants”) agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Contest. HOW TO ENTER THE CONTEST

Entry to the contest consists of completing and submitting the entry form anytime beginning at 12:00 am CST on November 25, 2023 and ending at 11:59 pm CST on December 17, 2023 (the “Submission Period”). Only one entry per person. Multiple entries will not be accepted. Entries may be submitted through any of the following methods of entry:

1. Crown Center Website

Eligible persons can enter the Contest by visiting crowncenter.com/stockingstuffers (the “Website”) and successfully completing the Contest registration form.

Participants who enter online must enter using the website entry submission form. Entries originating at any other web site or email address, including, but not limited to, commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Contest. The use of automated entry devices is prohibited; all such entries are void.

2. Crown Center Customer Service

Eligible persons without access to the internet or without an email address may enter the Contest by filling out an official entry form in person during normal retail hours at the Customer Service Desk inside the Crown Center Retail Shopping Center in Kansas City, Missouri during the Submission Period. Only one entry per person.

Sponsor is not responsible for: late, incomplete, incorrect, delayed, garbled, undelivered, or misdirected entries.

ENTRY REQUIREMENTS AND RESTRICTIONS

Once submitted, an entry cannot be deleted, canceled or modified. In order to be eligible, entries must actually be received by the Sponsor during the Submission Period. Entries received by the Sponsor before the start of the Submission Period or after the end of the Submission Period are VOID. Proof of submitting a Contest entry form will not be deemed by Sponsor to constitute proof of actual receipt by Sponsor of an entry. Those who do not follow all of the instructions, do not provide the required information in their entry form, or do not abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries made by any other individual or any entity, and/or using any e-mail address other than the Entrant's, or submitted at any other website, including, without limitation, commercial promotion subscription notification and/or entering service sites, will be declared invalid and disqualified. Your entry submission constitutes your representation of eligibility, consent to participate in Contest and consent for Sponsor to obtain, use, and transfer your name, address, and other information for the purpose of Contest administration. Entries that do not conform to these guidelines will be disqualified. Sponsor reserves the right to reject or disqualify any entry which Sponsor, in its sole and absolute discretion, determines to be inconsistent with the letter or spirit of the Official Rules or potentially damaging to its, the Contest's, or another's image or reputation.

WINNER DETERMINATION/NOTIFICATION

Sponsor will conduct a random drawing on December 18, 2023 to select a winner ("Winner") from all eligible entries received during the Submission Period. The Winner will be contacted by the Administrator on or about December 19, 2023 and must accept the Prize and return any required prize claim forms by January 15, 2024. If the Winner cannot be contacted or fails to timely respond, does not meet eligibility requirements, or does not complete the acceptance of the Prize by such date, Sponsor reserves the right to select a different Prize Winner. The odds of winning vary based upon the number of entrants and the quality of entries.

PRIZE AND APPROXIMATE RETAIL VALUE

The Stocking Stuffers 2023 Prize (“Prize”) consists of a Basket of Stocking Stuffer items from participating Crown Center merchants. Approximate retail value is \$343.00.

Any difference between the above-stated ARV of the Prize and the actual value of the Prize will not be awarded. Participants will receive a confirmation form with details via email. All other expenses associated with the Prize not mentioned herein are the responsibility of the Winner(s). The value of the Prizes set forth above represents Sponsor’s good faith estimate of the ARV thereof as of the publication date of these Official Rules.

GENERAL CONDITIONS

If for any reason the operation or administration of this Contest is impaired or incapable of running as planned for any reason, including but not limited to: (a) infection by computer virus, bugs; (b) tampering, unauthorized intervention; (c) fraud; (d) technical failures; or (e) any other causes or actions which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, the Sponsor reserves the right, at its sole discretion, to (i) disqualify any individual who tampers with the entry process, and (ii) to cancel, terminate, modify or suspend the Contest in whole or in part, at any time, without notice and award the Prize using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be (a) tampering or attempting to tamper with the entry process or the operation of the Contest or Sponsor’s Website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to the identity of the Winner based on an email address, the winning entry will be declared to be the authorized account holder of the email address in question submitted at time of entry. “Authorized account holder” is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

RELEASE AND LIMITATIONS OF LIABILITY

By participating in the Contest, Entrants agree to release and hold harmless the Sponsor, the Administrator, and their respective parents, employees, officers, directors, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies (collectively, the “Released Parties”) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of any prize, including, but not limited to: (a) any

technical errors that may prevent an Entrant from submitting an entry; (b) unauthorized human intervention in the Contest; (c) printing errors; (d) errors in the administration of the Contest or the processing of entries; or (e) injury, death, or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Contest or receipt of any prize. Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries.
